

## Investigative Summary From Dept of Children & Family

Information taken by DCF on 08/30/2021

Accusations against Yolanda Torricella Buck (cousin of the child) & Mark Buck (Ex-husband)

1. The cousin's husband touched Yolanda in an improper way. He touched her on her private parts and kissing her on the lips.

When they returned from Cuba, they accused me of trying to kiss her on the lips. That never happened. The child even told her mother in from of Yolanda & I that a kiss never happened. I have never kissed that child on the lips.

2. It's unknown if she's been penetrated but he gave her water to drink before they left and then she started to feel dizzy and not feeling well but she doesn't remember anything, but when she woke up her whole body was hurting and **she was inside a car**. It's unknown whether she doesn't remember or she's blocking the memory off.

**This is really sick; disgusting.** Albeit, it was never mentioned in the accusations of the injunction. This information came about on August 30<sup>th</sup>, 2021 — Two years after they had moved out of Yolanda's house, and 8 months after the injunction against us was dismissed.

Also, **in article # 6 of the injunction**, where she confided in her sister, WHY, didn't she mention this horrific sexual act to her sister. If this sexual act actually happened, it had to have happened before they went to Cuba.

**In PART II of this report (article 6)** there is a another version of this accusation, that was reported on August 2020. It's even sicker (more graphic) than this one. It seems this woman can't get her story straight.

3. The cousin and the cousin's husband would put porn on for her to watch with them.  
**This happened in 2018 but she's talking now.**

Equally disturbing allegation. Yolanda an I, do not watch porn. We only watched 1 movie with her, on June 22, 2019. It was a scary movie (fright night II). She didn't even watch it; she was playing with her phone.

4. Yolanda and her parents lived with the cousin and the cousin's husband because they came from Cuba.

They NEVER lived with the cousin's husband. He has his own residence.

5. The cousin's husband was being paid to watch Yolanda and during this time this was going on.

They have never paid me to watch the child. I was never even asked to "watched" the child, and was NEVER alone with the child.

6. **Yolanda was afraid to say anything because they threatened to kill her parents if she didn't do as they said.**

I absolutely love this one! **In the injunction**, (accusation # 9) she claims that Yolanda told the child that "If you tell you will all be in the street". It changed from that allegation to "We will kill your parents" **also in PART II (line 5)** is the same accusation, after I supposedly went in the shower to bathe her and rubbed her vagina, grabbed her butt, and rubbed her breast...

7. Yolanda confided in her sister that lives in Cuba because she was thinking about committing suicide and the sister told her parents. Yolanda and her parents no longer reside at the cousin's home.

Ironically, **in article 6 of the injunction** which says:

"The petitioner's father further states that upon arrival in Cuba, the petitioner confided in her older sister that the respondent had been acting inappropriately with her since 2018. The petitioner also told her sister that the respondent had forced her to watch pornography" They went to Cuba on June 23<sup>rd</sup>, 2019. Why did the child NOT confess that I had given her a drink of water, and she passed out and didn't know if she had been penetrated? As well, why didn't she confess that I frequently went in the shower to bathe her, and rub her vagina, grab her butt...? All of that would have had to have happened BEFORE they went to Cuba.

8. Yolanda is afraid and she's having nightmares.

Yeah Right! In a fake text to her mother (evidence they had submitted to our lawyer) Little Yoly claimed that: She couldn't concentrate in school as she was afraid of what might happen. This was in reference to a call to her dad where Yolanda asked if we could see her for a few minutes in their presence. We never spoke to the child. Whatever fear she supposedly had would have come from her parents.

9. Yolanda's afraid because she knows that the ap watches go to school and leaves from school. The mother has cameras set up at the home.

Yeah, Right! What fantasy world is this woman living in?

## Part II of the same report

### Summary of the allegations from the intake

On August 30<sup>th</sup>, 2020 the Florida abuse hotline received a report with concerns for sexual abuse

#### ALLEGED MALTREATMENT:

1. The child is now living with her mother and father in a separate home and a restraining order have been places on the uncle and his wife. The child informed the CPI that she was indeed sexually abused in the form of molestation by the uncle and physically disciplined by his wife if she did not do things to make the uncle happy.

Sorry! I loved that little kid like she was my own, so did Yolanda. She was NEVER molested or EVER disciplined by Yolanda. I have no idea why they call me "uncle" as I am not blood relative, nor is Yolanda her aunt. She is her second cousin.

2. The child explained that when her and her parents came from Cuba they were living with the paternal family. The child stated that they did not have a lot of money and would be working really hard to try to save money to get them into their own home.
3. She stated that the aunt and uncle first started to buy he nice things and would say things like if you don't give the uncle a kiss, they were going to take the toys away, or stating they wouldn't take her somewhere.

Ha! We took this poor, neglected little kid everywhere, and bought her lots of things, mostly clothes and/or shoes, because her parents didn't buy her anything. Toys? What toys?  
**And, there was no kiss necessary.**

4. Then she stated the uncle would do things like come in the shower to bathe her and rub on her vagina, grab her butt, or rub on her breast on multiple occasions.

What a joke! This sick, demented woman! I NEVER, EVER went in the shower. The mother has a vivid imagination; suitable to write Horror movie scripts. She belongs in Hollywood!

5. She stated that the threats then became if she tells he would kill her parents and the child became scared and would not say anything.

**Noted in article 6 of previous page.** It went from throwing them out in the streets (in the injunction, accusation # 5) to KILLING HER PARENTS!

6. On one occasion the child stated that her uncle and the aunt went to the mall and the uncle gave her a water bottle to drink and she stated after drinking the water she felt dizzy and does not remember anything but when she woke up, she stated that her vagina was in a lot of pain and her head was hurting.

**As mentioned in article 2 of the first page.** Except now, it seems that it was Yolanda & I that took the child to the mall and I gave her water to drink and that this time instead of her whole body hurting, her VAGINA was in a lot of pain and her HEAD was hurting...  
Question is: Was Yolanda witness to my doing something to little Yoly's vagina?

7. The child told her parents and her parents who at the time did not have anywhere else to go started allowing a family friend to watch the child and no longer allowed the child to be supervised by the aunt or uncle.

Well, that seems like a rational move on their parts. Just because they didn't have a place to go, their fix was to let a friend watch the child, because the aunt and uncle were DRUGGING and SEXUALLY ABUSING the child? I guess it just did not dawn on them to call the police.

8. There is currently an injunction on the uncle against the child as after the family moved out, he continued the harassed the family and even told the father that he is willing to give him a truck in exchange to be allowed to spend alone time with the child in which the parents declined.

**How she twists the truth around!** I offered the father to use my truck (that I no longer used) for free so he could provide for the little girl. **I DID ask that the innocent child NOT BE turned against us** (which they did, exploiting her for their revenge as they are doing here in this report)

Also I DID ask if Yolanda & I could visit the child for a few minutes outside by the pool in their presence. It was not conditional on using me truck.

9. The family now have no dealings with the aunt or uncle.

## NATURE OF MALTREATMENT:

1. The AP is of blood relation to the family. When the family came from Cuba they were staying back and forward with other family until the aunt allowed the family to stay in her spare room.

They were staying with the dad's stepson in a small garage apartment (converted garage) until the stepson & his wife couldn't stand them anymore and evicted them.

2. The uncle did not live with the aunt but started staying over more frequently stating that the child wanted him around.

Yes! I visited, and the child did want me around as she was always calling me to help with her homework and inviting me to have dinner with them as a family. Yolanda also invited me to have dinner with the family. The poor kid was not allowed to have friend at the house. I was her only friend.

3. The uncle would by things for the child and take them away if she was acting like what he considered a "Little Bitch" the uncle became very possessive of the child over time and him and the aunt did not want the child sleeping in the room with her parents and wanted the child to sleep in the front of the home by the front door.

I honestly believe that when little Yoly acted like a little bitch, was when her mother made her act like that, (possibly so that I would dislike her and stay away from her) I DID take a tablet away because she became very arrogant & disrespectful one day. That tablet was relatively costly and I felt that she didn't deserve it given her attitude.

In 3 of PART II above, it stated that I would take the toys away if she didn't give me a kiss, while here it stated that I would take toys away if she acted like what I considered a "Little Bitch". Which is it? The woman contradicts herself in the same document.

4. The child and the parents did not want the child to sleep out there by herself so they had the child in the room with them.
5. The uncle became obsessed and would even come in the room in the middle of the night to see where the child was sleeping despite him not living there. He states he only did this to say goodnight to the child.
6. The uncle then brought the child a bed to sleep in by herself. But got upset that the child was not sleeping in that bed.

7. The parents tried to get the child to sleep in the other bed but the child would still get in the bed with her parents.

Truth be told about the whole bed story: Yolanda & I felt it was highly inappropriate for the 11-year-old child to be sleeping with her parents, especially her dad who didn't even wear underwear. We cleaned out the closed in front porch and transformed into a bedroom for the kid. Her dad helped. I then took her to a mattress store and let her pick out a bed that she liked. We made a nice little room of her own so she could live normally.

In paragraph 4 above, the parents didn't want the child to sleep out there by herself, yet here in 7, they tried to get the child to sleep in the other bed.... where they didn't want her to sleep.

I usually left at 9:00pm or so. I don't know when 9:00pm became "middle of the night"

8. The uncle to this day is up to date with the family and the things they do on a regular and is able to quote their address verbatim despite the family moving away to get away from the AP's and moving again after the injunction he can quote both address in under 3 seconds of being asked.

Not going to dignify that. Too stupid.

9. The uncle has sent letters tracking the child being absent from school just based on what he calls observation even after the family left the aunts home.

No idea what she's talking about. Other than one day, Lazaro left a very nasty & threatening message on Yolanda's voicemail around 1:00pm on a Friday. In the middle of that voicemail little Yoly can be heard screaming YA! Like she wanted him to stop. I noted on my story (The Family From Hell) as to "why was this child not in school on a Friday afternoon at 1:00pm.

10. He tells how he went through her hamper can counted her dirty underwear because he felt like she needed to be taught how to wipe her privates. He also spoke on how he would go in the bathroom after the child to see if she was wiping.

Great story! One day I went to the bathroom to take a leak. On the way out I saw their clothes hamper, next to the door. It was so full that the lid couldn't close. On top of the pile was little Yoly's underwear. I thought it was odd as she was such a prude. Embarrassed for anyone to see her underwear. At the same time, I noticed huge stains of feces in those underwear.

I knew that the mother had told the child to NOT use the bathrooms at school. Why? I understand it's so she won't get raped... how absurd. I then mentioned this to Yolanda to find out why this poor child's underwear are so soiled. I was concerned for the child

And finally, many times I would use the bathroom after little Yoly had used it. However, she never flushed. Most of the time there was urine, and once in a while there was poop in the toilet. I never noticed toilet paper in the toilet, (didn't she wipe?) leading me to believe that that child was not taught basic feminine hygiene by her mother. And asked Yolanda to speak with the child about that subject.

**FINDINGS: The case is being closed as not substantiated for sexual abuse.**
